CLOTHING: The body presented in black shorts and a gray tank top. No jewelry is present.

EXTERNAL EXAMINATION: The body is that of a well-developed, well-nourished, white male appearing the reported age of 20 years. The body measures 6 foot 1 inch in length and weighs 163 pounds. The body mass index is 21.6. The body is well preserved and cold to touch. Rigor mortis is marked in the major muscle groups. Livor mortis is posterior and nonfixed.

The scalp hair is brown. There is no facial hair. The irides are gray. The pupils are equal. The corneae are clear. The sclerae and conjunctivae are free of petechiae. The nasal bones are intact by palpation. The nares are patent. The natural teeth are in good repair. The frenulum is intact. The oral mucosa and tongue are free of injuries. The external ears are patent, with blood oozing through. There are no piercings or earlobe creases.

The neck is symmetric and has no injuries or scars externally. The trachea is palpated at the midline.

The shoulders are symmetric and free of scars or injuries.

The chest has no scars and is symmetric.

The abdomen is symmetric and free of scars.

The external genitalia are those of a normally developed adult man. There are no injuries. The anus is unremarkable. The penis is circumcised. The testes are palpated in the scrotum.

The back is symmetric and is free of injuries or scars.

EVIDENCE OF INJURY:

Head: There is severe, gross deformity of the head with multiple, palpable fractures of the skull. Bloody fluid runs through the bilateral ear canals.

Torso: There are numerous palpable fractures of the bilateral ribs laterally and anteriorly. Aspiration of the bilateral chest cavities yields a large amount of blood.

On July 16, 2014 at 1508 hrs. I received a call from the Boynton Beach Police Department advising me of a suicide which have occurred on I-95 under the SW. 23rd St. overpass. According to the information I received this occurred approximately 1505 hrs. I advised I would respond and began my response at 1512 hrs. arriving on the scene at 1530 hrs.

The scene is the southbound lanes of I-95 on the south side of SW. 23rd Ave. overpass. The decedent's body is covered in a yellow plastic sheet and is lying in the next to the inside lane.

It is raining lightly and overcast. Crime scene investigators from the Boynton Beach Police Department measured the distance from the top of the railing to the surface of the road and it was 32'2". They also measured the distance from the South edge of the overpass to the location of the decedent's body and that measurement was 18 feet.

I photographed the scene and then I removed the sheet from the body of the decedent and photographed him. He is a white male wearing a pair of black shorts and a gray sleeveless T-shirt he has two nonmetallic bracelets on his right wrist and next to his left shoulder is a set of keys on a black lanyard.

According to the Boynton Beach police officers the decedent was observed to park his vehicle on the overpass above I-95, exit his vehicle, go to the South side of the overpass and throw himself over to the pavement below. The Boynton Beach Police Department ran a listing on the tag number and it came back registered to Ian Mautner, white male date of birth September 3, 1993 who resided at 2838 SW. 8th St., Boynton Beach, FL 33435. They were able to produce a driver's license photograph from the database which we compared at the scene and positively identified the decedent. I recovered a brown leather wallet from the decedent's right front pocket which contained his Florida driver's license with the same information identifying him as the database printout provided.

Examination of the decedent revealed no injuries to his body however he did have a large open fracture of the skull. I photographed these injuries and then had elite removal service transport the body to the morgue for examination.

It should be noted that no suicide note was found in the decedent's vehicle. I did have a conversation with the decedent's mother Linda Mautner on July 21, 2014 and during that conversation she indicated that her son had been suffering with a drug addiction problem for considerable amount of time.
